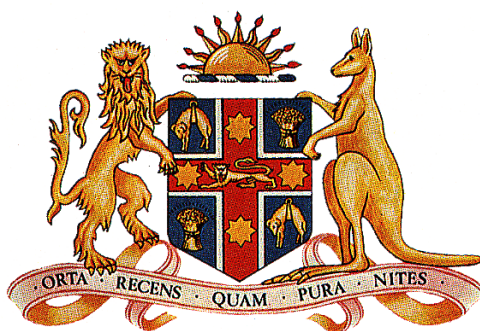

I, Natasha Mann, Commissioner for Fair Trading, Department of Customer Service, under the *Gas and Electricity (Consumer Safety) Act 2017* (the Act):

- (1) revoke, on and from the date on which this Order is published in the New South Wales Government Gazette, the Order signed on 2 August 2024 published in the New South Wales Government Gazette No 298 of 2 August 2024; and
- (2) pursuant to section 6(1) of the *Gas and Electricity (Consumer Safety) Act 2017* by this Order, declare the battery article of a class described in Schedule 1 to be, on and from the date on which this Order is published in the New South Wales Government Gazette, a high risk battery article.
- (3) pursuant to sections 12(2) and 12(3) of the *Gas and Electricity (Consumer Safety) Act 2017* by this Order, declare the electrical articles of a class described in Schedule 1 to be, on and from the date on which this Order is published in the New South Wales Government Gazette, declared electrical articles for the purposes of Part 2 of the *Gas and Electricity (Consumer Safety) Act 2017* and the specifications, including modifications, specified in Schedule 1 to be those applicable to electrical articles of that class.

Schedule 1

Declared High Risk Battery Articles under section 6; and Declared Electrical Articles under Section 12

A battery article of a class for the following:

1. E-BIKE

Interpretation:

In this schedule AS 15194:2016 and EN 15194:2017+ A1:2023 are modified to include an E-BIKE with a maximum continuous rated power not exceeding 500 watts.

AS 15194:2016; requirements are limited to Clauses 4.2 (all -except requirements of Electro Magnetic Compatibility), Clause 5 (all -except requirements of AS/NZS 1927) and Clause 6 (all -except requirements of AS/NZS 1927).

EN 15194:2017+A1:2023; requirements are limited to Clauses 4.2 (all -except requirements of Electro Magnetic Compatibility), Clause 5 and Clause 6. References to “EN 60335-2-29” (battery chargers) are replaced by “AS/NZS 60335.2.29”.

References to “EN 50604-1” in clause 4.2 of EN 15194:2017 + A1:2023 or AS 15194:2016 are replaced by “EN 50604-1:2016 +A1:2021 or IEC 62133-2:2017 or UL 2271”

NOTE: The specifications for AS 15194:2016 and EN 15194:2017 +A1:2023, compliance to the relevant clauses for batteries and battery chargers may be shown by submission of existing test reports and does not require additional retesting.

NOTE: Compliance to clauses 5 and 6 of EN 15194:2017 +A1:2023 or AS 15194:2016 may be verified by inspection of photographs and does not require further assessment.

1. E-BIKE cont.

An E-BIKE means a bicycle that:

- (a) is built to be propelled by human power through a belt, chain or gears; and
- (b) is equipped with one or more auxiliary propulsion motors; and
- (c) cannot be propelled exclusively by the motor or motors except in "startup assistance mode"; and
- (d) contains or is powered by a rechargeable lithium battery;

and includes –

- (e) any associated propulsion battery; and (f) any associated charger.

But does not include -

- (g) any vehicles that are described as road vehicles for the purposes of the *Road Vehicle Standards Act 2018* or any vehicles that require registration in New South Wales.

Class specification:

For an E-BIKE with a maximum continuous rated power exceeding 500 watts: UL 2849:2022

Other:

AS 15194:2016; (until 1 February 2027) or

EN 15194:2017 +A1:2023; or

UL 2849:2022

2. ELECTRIC SCOOTER

An ELECTRIC SCOOTER means a scooter that:

- (a) has a footboard supported by wheels aligned 1 in front of the other, and
- (b) is steered by handlebars that control the front wheel, and
- (c) is designed to be used by a single person, and
- (d) is propelled by an electric motor or motors, and
- (e) may also be propelled by — (i) gravity, or
(ii) the rider pushing 1 foot against the ground, and
- (f) does not have a seat or saddle; and
- (g) contains or is powered by a rechargeable lithium battery;

and includes -

- (h) any associated propulsion battery; and (i) any associated charger.

But does not include-

- (j) any vehicles that are described as road vehicles for the purposes of the *Road Vehicle Standards Act 2018* or any vehicles that require registration in New South Wales.

Class specification:

AS/NZS 60335.2.114:2018 (until 30 November 2026); or

AS/NZS 60335.2.114:2023; or

EN 17128:2020; or

UL 2272:2016 (until 1 February 2027); or

UL 2272:2024

3. SELF BALANCING SCOOTER

A SELF BALANCING SCOOTER means a ride-on device that:

- (a) has 1 or 2 wheels; and
- (b) has no steering grips, seat or handlebars; and
- (c) contains or is powered by a rechargeable lithium battery;

and includes -

- (d) any associated propulsion battery; and (e) any associated charger.

Note: Self-balancing scooters may also be known as *hoverboards, gliders, smart boards, sky walkers, monoboards, mod boards and battery powered selfbalancing personal transport devices*.

AS/NZS 60335.2.114:2018 (until 30 November 2026); or

AS/NZS 60335.2.114:2023; or

EN 17128:2020; or

UL 2272:2016 (until 1 February 2027); or

UL 2272:2024

4. ELECTRIC SKATEBOARD

An ELECTRIC SKATEBOARD means a skateboard

that:

- (a) is propelled by an electric motor or motors,
- (b) comprises a long board that is located close to the ground that supports the person,
- (c) is steered by tilting the board left or right,
- (d) has 2 wheels mounted on a single steerable axle —
 - (i) at the front of the board, and
 - (ii) at the rear of the board,
- (e) is fitted with an effective stopping system controlled by using brakes, gears or motor control,
- (f) does not have handlebars or a steering wheel, and
- (g) contains or is powered by a rechargeable lithium battery; and includes -
- (h) any associated propulsion battery; and (i) any associated charger.

Class specification:

AS/NZS 60335.2.114:2018 (until 30 November 2026); or

AS/NZS 60335.2.114:2023; or

EN 17128:2020; or

UL 2272:2016 (until 1 February 2027); or

UL 2272:2024

5. E-BIKE BATTERY

An E-BIKE BATTERY means:

a rechargeable lithium battery that intended to provide the power sources for the propulsion an E-BIKE.

Class specification:

EN 50604-1:2016 +A1:2021; or

IEC 62133-2:2017; or

UL 2271:2018 (until 1 February 2027); or

UL 2271:2023

6. E-MICROMOBILITY BATTERY

An E-MICROMOBILITY BATTERY means;

a rechargeable lithium battery that is intended to provide the power source for an ELECTRIC SCOOTER, a SELF BALANCING SCOOTER or an ELECTRIC SKATEBOARD.

Explanatory Note

The object of this Order is to declare parishes of Kincumber and Wallarah in the Central Coast local government area as a reconstruction area. This part of the State was directly or indirectly affected by a severe weather event from late March 2025, including strong winds, heavy rainfall and large coastal swells.

Part 1 Preliminary

1 Name of Order

This Order is the *Reconstruction Area (Central Coast Weather Event) Order 2025*.

2 Commencement

This Order commences on 21 May 2025 and is revoked 12 months after its commencement.

3 Definitions

In this Order:

Act means the *NSW Reconstruction Authority Act 2022*.

local government area means an area within the meaning of the *Local Government Act 1993*.

parish means a part of a county the administrative boundaries of which are described in the digital cadastral database maintained by Spatial Services in the NSW Department of Customer Service.

Part 2 Declaration of Reconstruction Area

4 Declaration of reconstruction area – the Act, s 40

The part of the State comprising the parishes of Kincumber and Wallarah in the Central Coast local government area is declared to be a reconstruction area.
